

## TERMS AND CONDITIONS 1 JANUARY 2026 TO 30 JUNE 2026

### HOMETEAMNS PROMOTION (THE “PROMOTION”)

1. This promotion for a complimentary one (1) year Group Personal Accident insurance (the “**Complimentary Insurance Policy**”) is available with any application for a free HomeTeamNS membership (the “**Promotion**”) submitted between 1 January 2026 and 30 June 2026 (both dates inclusive) (the “**Promotion Period**”). The Promotion is jointly organised by HomeTeamNS and Professional Investment Advisory Services Pte. Ltd. (“**PIAS**”). The Complimentary Insurance Policy is underwritten by Singapore Life Ltd. (“**Singlife**”) and arranged through PIAS. HomeTeamNS is the master policyholder of the Complimentary Insurance Policy.
2. To qualify for this Promotion, you must meet all the following criteria to be considered an “**Eligible Participant**”, You must:
  - a. be eligible for and submit an application within the Promotion Period to become a HomeTeamNS Ordinary or Associate member under this Promotion and have the application approved and the membership is in force; or
  - b. have been eligible for and submitted an application for HomeTeamNS Ordinary or Associate membership under the previous promotion for a complimentary 1-year Travel or Home Contents insurance held from 1 August 2023 to 31 July 2024 (both dates inclusive) jointly organised by HomeTeamNS and PIAS and have the application approved and the membership is in force.

PIAS reserves the right to verify the eligibility of any Eligible Participant for the Complimentary Insurance Policy.
4. The Complimentary Insurance Policy will commence only upon acceptance and written confirmation of your application by PIAS and shall be subject to the applicable policy terms and conditions.

5. An Eligible Participant must ensure that accurate and valid particulars (including your mobile number and email address) are provided to HomeTeamNS. PIAS shall not be liable if it is unable to contact an Eligible Participant in relation to the **Complimentary** Insurance Policy application due to inaccurate particulars provided (including an incorrect mobile number or email address).
6. Each Eligible Participant is entitled to one (1) free HomeTeamNS membership (as administered by and subject to such additional terms and conditions imposed by HomeTeamNS) and one (1) Complimentary Insurance Policy only during the Promotion Period.
7. The Complimentary Insurance Policy is non-transferable nor exchangeable for cash, credit or any other item whether in part or in whole. PIAS reserves the right, at its absolute discretion and without prior notice, to replace the Complimentary Insurance Policy with alternative coverage or items of similar value.
8. This Promotion is non-replaceable, non-cumulative and cannot be used in conjunction with any other promotions, offers, rewards, loyalty programmes and/or discounts.
9. By participating in this Promotion, you consent to HomeTeamNS collecting, processing, disclosing and/or transferring your personal data and other information (including your full name, mobile number, email address, date of birth, date of consent and member type) to PIAS. You further consent to PIAS collecting, processing, disclosing and/or transferring the aforementioned personal data and other information to PIAS' third-party service providers, agents and contractors of PIAS, and product providers, whether located in Singapore or overseas, for the following purposes:

  - b. for the underwriting, processing, administration and servicing of the Complimentary Insurance Policy, including engagement of third parties administering the policy and/or any related redemption arrangement, and any other parties PIAS may, reasonably consider necessary in connection with the Complimentary Insurance Policy as well as for administering, servicing or dealing with the financial advisory services provided by PIAS, including the administration of this Promotion, processing of any applications for financial products, engagement of third-party providers administering the Promotion and Complimentary Insurance Policy redemption, and managing any financial products that you have purchased pursuant to the financial advisory services provided by PIAS; and
  - c. for statistical, research, audit, compliance and regulatory purposes.

12. By participating in this Promotion, you accept that PIAS's decision on all matters relating to the Complimentary Insurance Policy and this Promotion shall be final and binding. If there is any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion and/or the Complimentary Insurance Policy, these terms and conditions will prevail.
13. A person who is not a participant in this Promotion shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions.
